




- Velocity Trade was founded in 2007 by an experienced group of industry professionals.

VTI is owned 100% by VTH. VTI is registered with Her Majesty's Revenue and Customs as a Money Broker (Bureau de Change and Money Transmitter), is regulated by the Financial Conduct Authority in the UK, FCA No. 497263 and as a Financial Service Provider in New Zealand.
- Velocity Trade Limited ("VTL"), New Zealand and Australia provides physical foreign exchange to broker dealers, corporations and institutions. Velocity Trade Limited holds an Australian Financial Services Licence from ASIC (Australian Securities and Investment Commission) and is registered with AUSTRAC. VTL is registered as a Financial Services Provider in New Zealand and is registered with Her Majesty's Revenue and Customs as a Money Broker in the UK.
- Velocity Trade LLC ("VTUS"), USA provides operational support for FX services and is owned 100% by VTH.
- Velocity Trade Canada, Canada 100% owned by VTH, currently dormant.
